No person shall be appointed to any post in the service by direct recruitment who is less than 18 years or more than 42 years of age on the last date of submission of application to this office. The candidate shall submit application on plain paper, duly affixed with his/her latest photograph on its top, containing details particulars i.e. name, father's/husband's name, date of birth, sex, educational qualifications, category, if any, permanent and postal address with cell-phone number and experience, if any, alongwith attested copies of relevant certificates besides two self addressed properly stamped envelopes. The applications should reach this office either by registered post or by hand, well before the closing date i.e.

The application should be addressed to the "The Secretary, District Legal Services Authority, Bhiwani and should have a reference to the advertisement published in the newspaper or displayed on the Notice Board.

The prescribed Stenography test shall be held at Halwasia Vidya Vihar Senior Secondary School, Rohtak Gate, Bhiwani at **2.00 PM on 23.01.2018**. The candidates shall report at the centre for the test at 1.00PM. The candidates shall bring their own typewriter, shorthand note book and pencil.

The candidates who would qualify the prescribed Stenography test shall have to produce 'pass' certificate of State Eligibility Test in Computer Appreciation and Applications issued by HARTRON or any other agency as approved by the Government, within a period of six months of the date of joining on the post.

The candidates possessing the qualifications as detailed in Rule 10(6) of the Haryana Legal Services Authority Group B, C & D employees (Recruitment and Conditions of Service) Rules, 2016 shall be exempted from the prescribed State Eligibility Test in Computer Appreciation and Applications ( SETC)

Written test for the aforesaid post of Clerk shall be held at Halwasia Vidya Vihar Senior Secondary School, Rohtak Gate, Bhiwani at **2.00 PM on 24.01.2018**. The candidates shall report at the venue latest by 1.00PM. The candidates shall bring their own clipboards. No candidate shall take any cellphone, gadget etc. in the Examination Hall.

The candidates applying for the post of Clerk who qualifies the written test as given above shall be called for type test of Hindi or English later on. The candidates who would qualify the prescribed typing test shall have to produce 'pass' certificate of State Eligibility Test in Computer Appreciation and Applications issued by HARTRON or any other agency as approved by the Government in this regard, within a period of six months of the date of joining the post. The candidates possessing the qualifications as detailed in Rule 10(6) of the Haryana Legal Services Authority Group B, C & D employees (Recruitment and Conditions of Service) Rules, 2016 shall be exempted from the prescribed State Eligibility Test in Computer Appreciation and Applications (SETC).

The recruitment/selection in respect of the aforesaid posts shall be conducted in accordance with the provisions/procedure prescribed under the Haryana Legal Services Authority Group B, C & D employees (Recruitment and Conditions of Service) Rules, 2016 and the instructions covering the subject issued by the Haryana Government from time to time.
